Personal data protection statement

This page will describe management of our web site as regards processing the personal data of users that visit us.

This informative report is provided to users of the services of the present web site in accordance with current legislation in the framework of the European Regulation no. 2016/679.

The information provided only applies to our web site and does not concern any web sites that may be visited by a user via external links.

Data controller

Visiting this site may result into the processing of data concerning identified or identifiable persons.

Any postal communications to the DPO must be sent in a sealed envelope to the attention of the DPO at the postal address of the data controller.

Place where data are processed

The treatments related to the services of the web site mentioned above, are only handled by technical staff in charge of processing, or by persons in charge of occasional maintenance operations. No data deriving from the web service are communicated or disseminated.

Purposes and legal basis of data processing

The personal data provided by users who submit requests or intend to use any services or products offered by the site as well as receive further specific content are used only to respond to requests or execute the service or performance requested. Personal data are communicated to

third parties only where this is necessary for this purpose. The legal basis of the processing is the need to give a feedback to the requests of the interested parties or to carry out activities foreseen by the agreements defined with the interested parties.

With the express consent of the user, the data may be used for commercial communication related to offers of products or other services of the owner. The legal basis of this treatment is the consent freely expressed by the interested party.

Apart from these hypotheses, users' browsing data are kept for the time strictly necessary for the management of processing activities within the limits established by law.

Type of data

Browser data

In the course of their routine work, the electronic systems and software procedures that operate this website may collect personal data which are inherently transmitted when using Internet communication protocols.

Such details are not collected to be matched with identified users, but, because of their nature, they could be processed or matched to details held by third parties so that users could be identified.

Such type of details include IP addresses or domain names of the computers used to log in to the website, URIs (Uniform Resource Identifier), time of querying, querying method, size of the file received as a reply, numerical code associated with the status of the server's reply (successfully completed, error, etc.) and other details of the user's operating system and digital environment. Such details are solely used to process anonymous statistics about the way the website is used and make sure it works properly, and they are immediately deleted once processed. Automatically-collected details may be used to investigate any alleged cyber-crime committed against the website.

Data provided voluntarily by users

Sending e-mail messages to the addresses mentioned on this website, which is done on the basis of a freely chosen, explicit, and voluntary option, entails acquisition of the sender's address, which is necessary in order to reply to any request, as well as of such additional personal data as is contained in the message(s).

Cookies

Cookies are short pieces of text used by websites and stored on your PC by your browser after authorization.

Aim of cookies is to simplify analysis of web data traffic or notify when a website has been visited. Cookies allow to web applications to send information to the users. No personal data are acquired by the site in this regard. No cookies are utilized for the transmission of personal information and no persistent cookies (i.e. tracking systems) are employed. The use of session cookies is strictly limited to transmitting session identifiers (consisting of random numbers generated by the server) necessary to allow safe and exploration efficient site. The so-called session cookies used on this site avoid the use of other techniques potentially prejudicial to the privacy of the users and not allow the acquisition of personal identification data.

Optional provision of data

Apart from what stated above in relation to navigation data, users are free to provide personal data, if requested in specific sections of the website. Absence of these data can lead to the impossibility to fulfil the request.

Data processing and data retention policy

Personal data are processed with automated tools for the time strictly necessary to achieve the purposes for which they were collected. Specific security measures are observed to prevent data loss, illicit or incorrect use and unauthorized access.

Data are not stored for longer than is absolutely necessary to pursuit the purpose declared here and will be deleted at the end of this period, unless the data must be kept for legal obligations or legal reasons.

Rights of the interested parties

The interested parties have the rights indicated by the article 7 of Legislative Decree 196/2003 and the article 15 and following articles of EU Regulation 679/2016, including the right to request the data controller to access personal data, to correct or delete them or limit the treatment that concerns them, to refuse the data handling, and the right of the data portability (article 15 and following articles of EU Regulation 679/2016); if the data processing is based on consent, there is the right to withdraw the consent at any time without jeopardizing the lawfulness of the treatment based on the consent given before the revocation.

if it fulfils certain conditions, the interested parties also have the right to lodge a complaint with the Guarantor (www.garanteprivacy.it) as the supervisory authority in accordance with the procedures laid down.

Within the limits and under the conditions provided in the law, the owner shall be obliged to respond to the requests of the interested party regarding personal data concerning him/her.

In particular, based on the current legislation:

1. The data subject shall have the right to obtain from the controller confirmation as to whether or not personal data concerning him or her are being processed, and, where that is the case, access to the personal data and the following information:

- the purposes of the processing;
- the categories of personal data concerned;
- the recipients or categories of recipient to whom the data have been or will be disclosed, in particular in the case of recipients in third countries or international organizations;
- whenever possible, the period for which the personal data will be stored, or if that is not possible, the criteria used to determine that period;
- the existence of the right to request from the controller rectification or erasure of personal data or restriction of processing of personal data concerning the data subject;
- the right to lodge a complaint with a supervisory authority;
- where the personal data are not collected from the data subject, any available information as to their source;
- the existence of an automated decision-making process, profiling included.

2. The data subject shall have the right to obtain from the controller the correction of any inaccurate personal data concerning him or her without undue delay. Taking into account the purposes of the processing, the data subject shall have the right to have incomplete personal data completed, including by means of providing a supplementary statement.

3. The data subject shall have the right to obtain from the controller the erasure of personal data concerning him or her without undue delay and the controller shall have the obligation to delete personal data without undue delay as provided for by the legislation in force.

The controller shall inform each recipient of the personal data about rectification or erasure of personal data or restriction of processing as provided for by the legislation in force.

4. The data subject shall have the right to obtain from the controller the restriction of processing.

5. The data subject has the right to receive, in a structured, commonly used and automatically readable form, the personal data concerning him/her provided to a data controller and has the right to transmit such data to another data controller without impediments from the data controller who supplied them.

In order to exercise the rights listed above, the data subject must submit a request using the contact details indicated above.

The present version of the processing of personal data policy was updated on 23 May 2018.

Cookies policy

This document is drafted by the data controller, as the data controller of personal data resulting from browsing on this website.

MCR informs the user that the Website uses technical cookies to guarantee an optimal browsing experience. This policy of cookies ("cookies policy"), which must be read to supplement the information provided in the Privacy Policy, is used to describe the types of cookies and other technologies used on the Site, as well as the reasons and conditions of use of cookies . We inform you that some cookies are necessary to allow a correct browsing of the site and by continuing to browse you provide your consent of the use of these cookies.

The user can however avoid the installation of cookies by configuring the settings of his browser or disabling the use of the sites through the browser directly, as specified in detail below.

Use of Cookies

The "Website" employs cookies to make our services simple and efficient for users who view the pages of the site. A minimum amount of information will be entered in the users devices (computers and mobile devices) as small text files called "cookies" saved in the directories of the user's web browser. There are various types of cookies, some to make more efficient the use of the Site, others to enable certain features.

Type of Cookies

Technical cookies

This type of cookie allows the proper functioning of certain sections of the Site. There are two categories:

- persistent cookies: once the browser is closed they are not destroyed but remain until the expiration date
- session cookies: they are destroyed every time the browser is closed

These cookies are always sent from our domain and are necessary to view the site correctly and, in relation to the technical services offered, they will always be used and sent, unless the user does not change the settings of your browser (thus affecting the visualization of pages of the site).

Analytical cookies

These cookies are used to collect information on the use of the site. The site will employ this information in respect of anonymous statistical analysis in order to improve the use of the Site and to make the content more interesting and relevant to the wishes of users. This type of cookie collects anonymous data on the activity of users and how they arrived to the Site. Analytical cookies are sent from the site itself or from third-party domains.

Cookies analysis for third-party services

These cookies are used to collect information on the use of the Site by users in anonymous form such as page views, time spent, traffic sources of origin, geographic origin, age, gender and interests for the purposes of marketing campaigns . These cookies are sent from third-party domains external to the Site.

Cookies to integrate products and functions of third-party software

This type of cookie incorporates features developed by third parties within the pages of the Site as icons and preferences expressed in social networks in order to share the contents of the site or for the use of services, third-party software (such as software generate maps and additional software that offer additional services). These cookies are sent from third-party domains and partner sites that offer their functionality in the pages of the Site.

Profiling Cookies

Those cookies are needed to create user profiles in order to send advertising messages in line with the preferences expressed by the user within the pages of the site. The site, according to current legislation, it is not required to seek consent for technical cookies and analytics ones, as necessary to provide the required services. For all other types of cookies consent you may be expressed by the user with one or more of the following modes:

- By specific configurations of the browser or its programs used to navigate pages that make up the site.
- By changing settings in the use of third-party services

Both of these solutions might prevent you from using or view parts of the Website.
